

We Watch 247- Terms & Conditions of Trade

1.	Definitions	
U	"Seller" shall mean We Watch 247 its successors and assigns or any person acting on behalf of and with the authority of 24-7Security Limited.	(ii) Failure on the part of the Customer to follow any instructions or guidelines provided by the Seller, or
1.2	"Customer" shall mean the person or entity described as such on the invoices, application for credit, quotation, work authorisation or any other forms to which these terms and conditions apply, and shall mean any person acting on behalf of and with the authority of such person or entity.	(iii) Any use or any Goods otherwise than for any application specified on a quote or order form; or
1.3	"Guarantor" means that person (or persons), or entity, who agrees to be liable for the debts of the Customer on a principal debtor basis.	(iv) The continued use or any Goods after any defect becomes apparent or would have become apparent to a reasonably prudent operator or user; or
1.4	"Goods" shall mean Goods supplied by the seller to the Customer (and where the context so permits shall include any supply of Services as hereinafter defined) and are as described on the Invoice, s, quotation, work authorisation or any other forms as provided by the Seller to the Customer.	(v) Fair wear and tear, any accident or act of God.
1.5	"Services" shall mean any services supplied by the Seller to the Customer and includes any advice or recommendations (and where the context so permits shall include any supply of Goods as defined above)	(b) The warranty shall cease if the Seller shall thereafter in no circumstances be liable under the terms or the warranty if the workmanship is repaired, altered or overhauled without the Seller's consent.
1.6	"Price" shall mean the COST of the Goods as agreed between the Seller and the Customer subject to clause 3 or this contract.	(c) In respect of all claims the Seller shall not be liable to compensate the Customer for any delay in either replacing or repairing the workmanship/Goods or in properly assessing the Customer's claim.
2.	Acceptance	10.3 For Goods not manufactured by the Seller, the warranty shall be the current warranty provided by the manufacturer of the Goods. The Seller shall not be bound by nor responsible for any term, condition, representation or warranty Other than that which is given by the manufacturer of the Goods.
2.1	Any Instructions received by the Seller from the Customer for the supply of Goods and/or the Customer's acceptance of Goods supplied by the Seller shall constitute acceptance of the terms and conditions contained herein.	11. Sale of Goods Act 1893 and Sale of Goods and Supply of Services Act 1980
2.2	Where more than one Customer has entered into this agreement, the Customer, s shall be jointly and severally liable for all payments of the Price.	11.1 This agreement is subject to the provisions of the Sale of Goods Act 1893 and the Sale of Goods and Supply of Services Act 1980 in all cases except where the Customer is contracting within the terms of a trade/business (which cases are specifically excluded)
2.3	UxIn acceptance or these terms and conditions by the Customer the terms and conditions are irrevocable and can only be amended with the written consent of the Seller.	11.2 Notwithstanding clause 11.1 nothing in this agreement is intended to have the effect of contracting out of any applicable provisions of the Sale of Goods Act 1893 (in particular sections 12-15), or the Sale of Goods and Supply of Services Act 1980, or any laws or legislation governing the rights of consumers, except to the extent permitted by those Acts laws or legislation.
2.4	The Customer undertakes to give the Seller at least fourteen (14) days notice of any change in the Customer's name, address and/or any other change in the Customer's details.	11.3 In particular where the Customer buys Goods as a consumer the provisions of Clauses 8, 9 and 10 above shall be subject to any law or legislation governing the rights of consumers.
3.	Price And Payment	12. Intellectual Property
3.1	At the Seller's sole discretion the Price shall be either:	12.1 Where the Seller has designed, drawn or written Goods for the Customer, then the copyright in those designs and drawings shall remain vested in the Seller, and shall only be used by the Customer at the Seller's direction.
(a)	as indicated on invoices provided by the Seller to the Customer in respect of Goods supplied; or	2.2 The Customer warrants that all designs or instructions to the Seller will not cause the Seller to infringe any patent, registered or unregistered trademark in the execution of the Customer's order.
(b)	the Seller's quoted Price (subject to clause 3.2) which shall be binding upon the Seller provided that the Customer, shall accept the Seller's quotation in writing within thirty (30) days.	13. Default & Consequences Of Default
3.2	The Seller reserves the right to change the Price in the event of a variation to the Seller's quotation.	13.1 Interest on overdue invoices shall accrue from the date when payment becomes due daily until the date of payment at a rate of 2.5% per calendar month and such interest shall compound monthly at sunset, a rate as well as before any judgment
3.3	At the Seller's sole discretion a deposit may be required.	13.2 If the Customer defaults in payment of any invoice when due, the Customer shall indemnify the Seller from and against all costs and disbursements incurred by the Seller in pursuing the debt including legal costs on a solicitor and own client basis and the Seller's collection agency costs.
3.4	Time for payment for the Goods shall be of the essence and will be stated on the invoice or any other invoice. If no time, s stated then payment shall be due seven (7) days following the date of the invoice.	13.3 Without prejudice to any other remedies the Seller may have, if at any time the Customer is in breach of any obligation (including those relating to payment), the Seller may suspend or terminate the supply of Goods to the Customer and any of its other obligations under the terms and conditions. The Seller will not be liable to the Customer for any loss or damage the Customer suffers because the Seller exercised its rights under this clause.
3.5	At the Seller's sole discretion:	13.4 If any account remains overdue after thirty (30) days then an amount of the greater of £20.00 or 10.00% of the amount overdue (up to a maximum of £200) shall be levied for administration fees which sum shall become immediately due and payable.
(a)	payment shall be due on delivery of the Goods, or	13.5 Without prejudice to the Seller's other remedies at law the Seller shall be entitled to cancel all or any part of any order of the Customer which remains unperformed in addition to and without prejudice to any other remedies and all amounts owing to the Seller shall, whether or not due for payment, become immediately payable in the event that
(b)	payment shall be due before delivery of the Goods, or	(a) any money payable to the Seller becomes overdue, or in the Seller's opinion the Customer will be unable to meet its payments as they fall due; or
(c)	payment for approved Customers shall be made by instalments in accordance with the Seller's payment schedule, or	(b) the Customer becomes insolvent, convenes a meeting with its creditors or proposes or enters into an arrangement with creditors, or makes an assignment for the benefit of its creditors; or
(d)	payment for approved Customers shall be due thirty (30) days following the end of the month in which a Statement is posted to the Customer's address or address for notices.	(c) a receiver, manager, liquidator (provisional or otherwise) or similar person is appointed in respect of the Customer or any asset of the Customer.
3.8	Payment will be made by cash, or by cheque, or by bank cheque or by any other method as agreed between the Seller and the Customer.	14. Security And Charge
3.7	VAT and other taxes and duties (that may be applicable shall be added to the Price except when they are expressly included in the Price.	14.1 Despite anything to the contrary contained herein or any other rights which the Seller may have howsoever:
4.	Delivery Of Goods	(a) where the Customer and/or the Guarantor (if any) is the owner of land, realty or any other asset capable of being charged, both the Customer and/or the Guarantor agree to mortgage and/or charge all of their joint and/or several interest in the said land, realty or any other asset to the Seller or the Seller's nominee to secure all amounts and other monetary obligations payable under the terms and conditions. The Customer and/or the Guarantor acknowledge and agree that the Seller, (or the Seller's nominee) shall be entitled to lodge where appropriate a caveat, which caveat shall be released once all payments and other monetary obligations payable hereunder have been met.
4.1	At the Seller's sole discretion delivery of the Goods shall take place when the Customer takes possession of the Goods at the Customer's address (in the event that the Goods are delivered by the Seller or the Seller's nominated carrier).	(b) should the Seller elect to proceed in any manner in accordance with this clause and/or its sub clauses, the Customer and/or Guarantor shall indemnify the Seller from and against all the Seller's and disbursements including legal costs on a solicitor and own client basis.
4.2	At the Seller's sole discretion the costs of delivery are included in the Price.	(c) The Customer and/or the Guarantor (if any) agree to irrevocably nominate, constitute and appoint the Seller or the Seller's nominee as the Customer's and/or Guarantor's true and lawful attorney to perform all necessary acts to give effect to the provisions of this Clause 14.
4.3	The Customer shall make all arrangements necessary to take delivery of the Goods whenever they are tendered for delivery. In the event that the Customer is unable to take delivery of the Goods as arranged then the Seller shall be entitled to charge a reasonable fee for redelivery.	15. Cancellation
4.4	Delivery of the Goods to a third party nominated by the Customer is deemed to be delivery to the Customer for the purposes of this agreement.	15.1 The Seller may cancel these terms and conditions or cancel delivery of Goods at any time before the Goods are delivered by giving written notice. On giving such notice the Seller shall repay to the Customer any sums paid in respect of the Price. The Seller shall not be liable for any loss or damage whatever arising from such cancellation.
4.5	The Seller may deliver the Goods by separate instalments. Each separate instalment shall be invoiced and paid for in accordance with the provisions in these terms and conditions.	15.2 In the event that the Customer cancels delivery of Goods the Customer shall be liable for any loss incurred by the Seller (including, but not limited to, any loss of profits) up to the time of cancellation.
5.	Risk	16. Data Protection Act 1988 & Data Protection Act 2003
5.1	If the Seller retains ownership of the Goods nonetheless, all risk for the Goods passes to the Customer on delivery.	16.1 The Customer and the Guarantor (if separate to the Customer) authorises the Seller to:
5.2	If any of the Goods are damaged or destroyed following delivery but prior to ownership passing to the Customer, the Seller is entitled to receive all insurance proceeds payable for the Goods. The production of these terms and conditions by the Seller is sufficient evidence of the Seller's rights to receive the insurance proceeds without the need for any person dealing with the Seller, to make further enquiries.	(a) collect, retain and use any information about the Customer for the purpose of assessing the Customer's creditworthiness or marketing products and services to the Customer; and
6.	Title	(b) disclose information about the Customer, whether collected by the Seller from the Customer directly or obtained by the Seller from any other Source, to any other credit provider or any credit reporting agency for the purposes of providing or obtaining a credit reference, debt collection or of listing (whether before or after judgement) a default by the Customer on publicly accessible credit reporting databases.
6.1	It is the intention of the Seller and agreed by the Customer that ownership of the Goods shall not pass until:	16.2 Where the Customer is an individual the authorities under clause 16.1 are authorities or consents for the purposes of the Data Protection Act 1986 & Data Protection Act 2003.
(a)	the Customer has paid all amounts owing for the particular Goods, and	16.3 The Customer shall have the right to request the Seller for a copy of the information about the Customer retained by the Seller and the right to request the Seller to correct any incorrect information about the Customer held by the Seller.
(b)	the Customer has met all other obligations due by the Customer to the Seller in respect of all contracts between the Seller and the Customer.	17. Unpaid Seller's Rights
6.2	Receipt by the Seller of any form of payment other than cash shall not be deemed to be payment until that form of payment has been honoured, cleared or recognised and until then the Seller's ownership or rights in respect of the Goods shall continue.	17.1 Where the Customer has left any item with the Seller for repair, modification, exchange or for the Seller to perform any other service in relation to the item and the Seller has not received or been tendered the whole of the Price, or the payment has been dishonoured, the Seller shall have:
6.3	It is further agreed that:	(a) a lien on the item;
(a)	where practicable the Goods shall be kept separate and identifiable until the Seller shall have received payment and an other obligation of the Customer are met and	(b) the right to retain the item for the Price while the Seller is in possession of the item;
(b)	until such time as ownership of the Goods shall pass from the Seller to the Customer the Seller may give notice in writing to the Customer to return the Goods or any of them to the Seller. Upon such notice the rights of the Customer to obtain ownership or any other interest in the Goods shall cease; and	(c) a right to sell the item.
(c)	the Seller shall have the right of stopping the Goods in transit whether or not delivery has been made; and	17.2 The lien of the Seller shall continue despite the commencement of proceedings, or judgment for the Price having been obtained.
(d)	if the Customer fails to return the Goods to the Seller then the Seller or the Seller's agent may enter upon and into and premises owned, occupied or used by the Customer, or any premises as the in, title of the Customer, where the Goods are situated and take possession of the Goods; and	18. General
(e)	the Customer is only a bailee of the Goods and until such time as the Seller has received payment in full for the Goods then the Customer shall hold any proceeds from the sale or disposal of the Goods on trust for the Seller, and	18.1 If any provision of these terms and conditions shall be invalid, void, illegal or unenforceable the validity, existence, legality and enforceability of the remaining provisions shall not be affected, prejudiced or impaired.
(f)	the Customer shall not deal with the money or the Seller in any way which may be adverse to the Seller; and	18.2 These terms and conditions and any contract to which they apply shall be governed by the laws of Ireland and are subject to the jurisdiction of the courts of Ireland.
(g)	the Customer shall not charge the Goods in any way nor grant nor otherwise give any interest in the Goods while they remain the property of the Seller; and	18.3 The Seller shall be under no liability whatever to the Customer nor any indirect, loss and/or expense (including loss of profits) suffered by the Customer arising out of breach by the Seller of these terms and conditions.
(h)	the Seller can issue proceedings to recover the Price of the Goods sold notwithstanding that ownership of the Goods may not have passed to the Customer, and	18.4 In the event of any breach of this contract by the Seller the remedies of the Customer shall be limited to damages. Under no circumstances shall the liability of the Seller exceed the Price of the Goods.
(i)	until such time that ownership in the Goods passes to the Customer, if the Goods are consigned into other products the parties agree that the Seller will be the owner of the end products.	18.5 The Customer shall not be entitled to set off against or deduct from, the Price any sums owed or claimed to be owed to the Customer by the Seller.
7.	Customer's Disclaimer	18.6 The Seller may license or subcontract all or any part of its rights and obligations without the Customer's consent.
7.1	The Customer hereby disclaims any right to rescind, or cancel the contract or to sue for damages or to claim restitution arising out of any misrepresentation made to the Customer, by the Seller and the Customer acknowledges that the Goods are bought relying solely upon the Customer's skill and judgment	18.7 The Seller is not responsible for the filling, reflow, these conditions at any time, if, following any such review, there is to be any change to these terms and conditions, then, that change will take effect from the date on which the Seller notifies the Customer of such change. Except where the Seller supplies further Goods to the Customer and the Customer accepts such Goods, the Customer shall be under no obligation to accept such changes.
8.	Defects	18.8 Neither party shall be liable for any default due to any act of God, war, terrorism, strike, lock out, industrial action, fire, flood, drought, storm or other event beyond the reasonable control of either party.
8.1	The Customer shall inspect the Goods on delivery and shall within seven (7) days notify the Seller of any alleged defect, shortage in quantity, damage or failure to comply with the description or quote. The Customer shall afford the Seller an opportunity to inspect the Goods within a reasonable time following delivery if the Customer believes the Goods are defective in any way. If the Customer shall fail to comply with these provisions the Goods shall be presumed to be free from any defect or damage. For defective Goods, which the Seller has agreed in writing that the Customer is entitled to reject, the Seller's liability is limited to either (at the Seller's discretion) replacing the Goods or repairing the Goods.	
9.	Returns	
9.1	Returns will only be accepted provided that:	
(a)	the Customer has complied with the provisions or clause 8.1; and	
(b)	the Seller has agreed in writing to accept the return of the Goods; and	
(c)	the Goods are returned at the Customer's cost within seven (7) days of the delivery date; and	
(d)	the Seller will not be liable for Goods which have not been stored or used in a proper manner; and	
(e)	the Goods are returned in the condition in which they were delivered and with all packaging material, brochures and instruction material as new condition as is reasonably possible in the circumstances.	
9.2	The Seller will not accept the return of Goods for credit.	
10.	Warranty	
10.1	Subject to the conditions of warranty set out in Clause 10.2 the Seller warrants that if any defect in any workmanship or the Seller becomes apparent and is reported to the Seller within twelve (12) months of the date of delivery (time being of the essence) then the Seller will either (a) the seller's sole liability) repair the defect or remedy the workmanship.	
10.2	The conditions applicable to the warranty given by Clause 10.1 are:	
(a)	The warranty shall not cover any defect or damage which may be caused or partly caused by or arise through:	
(i)	Failure on the part of the Customer to properly maintain any Goods; or
